Per the sheriff, this does have all the signs of someone looking to seek approval and someone that's not from here/new here. I believe the sheriffs will do everything they can to pursue the suspect and it's in gods hands now. Knowing what I know, I have followed the cookie crumbs and I believe with enough time the community can put those same cookie crumbs together, without access to the videos. It's all on this page, and not hard to narrow it down. Who was seeking approval, with little understanding of our culture? Who was at the meeting knowing my car wasn't with me? Who was looking to set the narrative that I was possibly faking it? Who has access to a used dogs tennis ball? Who felt like I was attacking them/their family and friends? I'll let you all do the investigation, as the sheriffs and myself have.

I know you're reading this and I hope you now realize we all support each other no matter how much we vent. I would hope you find the courage to speak up before this investigation gets any deeper. I'm not looking to get you in trouble, I am a man of god, I believe in forgiving, and I know you just made a mistake. I've made many myself, but I can't help you if you don't help yourself.

I carried my family Bible in my back pocket all day yesterday to bring me the sprits I needed to protect me and the confidence to know that whatever happened was my true path.
